18 19 20	The undersigned parties hereby agree to amend the Original Broker Agreement as follows:		
21	Real estate brokerage commissions are not set by law and are fully negotiable.		
23 24 25 26	 The parties understand that the MLS (multiple listing service) where the property was listed for sale will no longer publish offers of compensation to selling brokers or other buyer representatives. Seller and listing broker agree that the offer of compensation may be removed from the MLS prior to August 17, 2024. 		
27 28 29	 Seller, if having already agreed to offer compensation to selling brokers, authorizes listing broker to continue to make such offers through all other non-MLS means, as determined by the broker. Listing broker is authorized to enter into broker-to-broker agreements to memorialize said offers. 		

- The listing broker shall always conspicuously disclose to sellers and obtain seller approval in advance for any payment or offer of payment that the listing broker or seller will make to another broker, agent, or other representative acting for buyers.
- Buyer Agreements Only: In the event that buyer's agreement with selling broker set compensation at a rate to be determined based off what seller or listing broker was offering, or at a "not less than" rate, said agreement is modified to provide that selling broker will be paid a fee of % of final sales price or a flat fee of \$
- The selling broker shall not receive compensation for brokerage services from any source that exceeds the amount or rate agreed to in the compensation or representation agreement with the buyer.

To the extent the terms of this ADDENDUM modify or conflict with any provisions of the Original Broker Agreement including all prior Addendums, these terms shall control. All other terms of the Original Broker Agreement including all prior Addendums not modified by this ADDENDUM shall remain the same. Upon its execution by Broker and Buyer or Seller, this agreement is made an integral part of the Original Broker Agreement.
